**Promoting Quality Professional Supervision:** IASW Standards for Social Workers 2016




The IASW launched a working document on Promoting Quality Social Work Supervision at the National Conference in response to the requests and needs of members for core standards in this area. Copies have been posted out to members.



The report was launched in June by the Irish Association of Social Workers, Age Action, the Alzheimer Society of Ireland and the School of Social Policy, Social Work and Social Justice, UCD. The research was based on a nationwide survey of social workers working with older people, including people living with dementia. It also includes

Work Conference, the AGM and the IASW Social Work Awards, which were a great success. The IASW Supervison Standards for Social Workers were launched at the conference and I hope they will be a very useful resource for all social workers, supervisors and supervisees in the years ahead. While services may reconfigure and reporting relationships vary, the IASW is clear that all social workers need to access supervision from a trained social work supervisor of an appropriate manager grade.

The first meeting of the new IASW Board will take place on 25th July and in the mean time the office staff and the existing Board members are continuing to work on your behalf. The IASW has regular meetings with Tusla and hopes to work in partnership particularly in relation to their excellent CPD strategy framework. The summer journal, guest edited by Sarah Donnelly, is approaching its completion. The IASW continues its advocacy work and is currently advocating on behalf of vulnerable persons who require home care packages. The IASW remains concerned that some social workers do not have a reporting relationship to a Principal Social Worker. In particular, the IASW is concerned that some HSE CHO areas are amalgamating the role of Principal Social Worker to cover both CAMHS and Adult Mental Health Services, and the IASW is currently advocating in relation to this matter. The IASW is not a staff representative body/ union but it is a professional body that takes seriously its objective to advocate for best practice standards.


